***YOUR AFFIANT SAYS THAT THE FACTS IN SUPPORT OF THE ISSUANCE OF THE SEARCH WARRANT ARE AS FOLLOWS:***

Your Affiant is Officer Ross Tisdell 8039Y of the Oakland Police Department, Oakland, California. I am an investigator with the Oakland Police Department. I have been a police officer in Oakland since July 1996. I am currently assigned to the Oakland Police Department's Youth and Family Services Division as an investigator in the Special Victim's Unit. My primary area of investigation is Sexual Assault and Child Abuse. As an officer and investigator, I have investigated or assisted in excess of 300 suspected sexual assaults and child abuse investigations involving neglect, physical abuse, sexual abuse, and child exploitation.

I have interviewed in excess of 100 persons who were reported or there was probable cause to believe, were the victims of sexual assault or child abuse. As a result of investigations, serving or assisting in the service of search warrants or reviewing evidence from other investigator's cases, I have become familiar with the victim's and the suspect's actions with regards to sex crimes. I have been involved in numerous cases where narcotics and firearms have been recovered. I have testified in Superior Court as an expert for the possession and sales of crack cocaine.
