By using a sound generator to provide the sound, and a headphone amplification system, *(a device to focus your hearing so as to increase the sensitivity of what one is listening to)* I have produced a set of voices by effectively controlling the sound to pronounce words through my own mental powers.

So I Norma Ortiz state that in the month of June 2006, I witnessed Phillip provide a demonstration at my place of business, controlling a voice or set of voices that are unearthly in nature. I have signed this affirmation to confirm my witnessing of this event.

This letter will help provide a powerful new insight concerning a type of problematic behavior that sends people on a never ending course of unproductive immoral development. It is built on the basic premise you move towards what you think about which is a scriptural key. (Matthew 4:4) *Every word from my father's mouth.* By going deeper into examining ones thoughts and beliefs on the bases of a knowledgeable awareness about the body, mind and the physics' behind our well being, then the analytical protocols needed to comply to the orderly running of ones mental health can provide a more capable means of growth.

In order to help and automatically protect a person from the many aggressive disorders known to infect our minds we need a clearer understanding of how to redevelop adults as well as providing for a parent to knowledgeably address their children.

Out of control behavior is everywhere, in every walk of life undermining the lives of its many victims. It stems and grows from the impact of self-talk, building a positive or negative self-image. The degree to which we vividly imagine an experience determines how it is stored in our subconscious as reality. Here is where a sexual predator (or any poor behavior) reinforces it self as the negative self-image is moving towards the problem. This thought process is unknown to them thus they end up unknowingly setting themselves up to become their own victim by seeding and strengthening their own belief system.

For re-growth to be truly effective and consistent, we need a quality means of understanding the internal controls of the physical mind and body and a way to supply people with a value system that is constructive in order for the servomechanism or auto pilot to provide a means of dissuading negative behavior. To provide understanding and growth a more constructive and healthy term of observations is needed this will start a new process of evaluation that can lead and provide the internal freedoms an individual needs. Then a person can see and feel the effects of healthy thinking and the rewards that come along with it. Other wise that person will be consumed by the physical

laws that govern our minds and bodies overriding the laws of the land that make a better life for us all.

Having a clearer understanding of how our physical needs and the world's interpretations of those needs are in conflict is important, as the entertainment world misleads people in to experiencing fantasies about sex and violence. This distortion of reality is a major problem leaving humans almost helpless. But if they can experience the rewards they can physically attain by using the thought process in a manner consistent with reality it can provide needed input to start motivating their growth. People are filled with many different types of experiences and memories that lead them in the wrong direction.

How to handle these problems will be apart of an upcoming program, for now understand each person has different personal qualities that become investment points to build renewing freedoms on. Let's label them as investment equities built up in a person that can play a powerful role in a more rapid recovery. By using what ever morally healthy thoughts they have already established allows them to better understand how reestablishing these pathways are a means of redeveloping his/her motivation.

With the proper knowledge and guidance they can begin to branch out and accomplish growth through their own established foundation of qualities, *(whatever those may be.)* Understand we need to re-grow through compassion and justice, in order to reach a persons personal desires, finding their highest degree of qualities working from that foundation. Without these types of qualities to control from we only become a noise to those who have these problems. In order to bring a comprehensive and knowledgeable awareness to someone else we need to reach them, and in my case because of my background I have found sound principles through a most unprecedented channel that has allowed me to examine and bring about an accounting of reality, it delivered me to a pathway of sound reasoning.

All this would be impossible without the personal ability to process complex issues concerning love and how it affects our ability to cope and change. This experience or awakening eventually led me to the next stage of redeveloping my awareness concerning this age-old problem.

In basic terms it is the age old struggle between right and wrong that is holding the human race back from discovering a freedom so capable that the renewing of ones mind becomes a simpler reality than anything we have ever believed or experienced educationally as a society. When trying to change any long term behavior humans struggle with the automatic that leads them right back to the helplessness of the servomechanism as it is part of the problem with any type of dysfunctional behavior.

This freedom is so complete that it needs no tune-up's once firmly established, as the auto pilot undermines any new inappropriate input it also maintains behavior other wise the healing of certain types of behaviors become an oppressive state of affairs. For me it reorganized and replaced an internal thought process with such unequivocal success that it literally redefines the possibilities.

These types of issues are frustrating the courts and law enforcement to the extent of sheer madness making it obvious people need knowledge that is not undermining them.

The following experience is encouraging, capable of enlightening and providing solid hope for everyone who suffers from the many forms of aggressive sexual behavior as well as other problematic behaviors. Please keep in mind this is not a complete description or an exact pathway being defined. How to achieve this freedom and what in general took place has led to a complete

recovery which is not detailed in this letter rather it is my intention to explain first that something new has been accomplished successfully, and will in time lead to a major development. This type of re-growth will only take place when humans take a mature stand to examine what the field of psychology has been trying to explain concerning development as they know what is taking place but are unable to provide due to the freedoms we have to make poor choices. So please be advised this is not a form of instructional therapy it is insight to an up and coming new means of handling many different problems. In time new light will be shed on what is taking place and what is causing these types of problems to be so unmanageable.

Before proceeding please be aware that not all people who suffer from these types of problems are happy with their behavior and do experience major depression after ejaculation. Some consider and desire to stop as emotional, and moral development can lead them to even hate their actions and have feelings of remorse. Unfortunately the next time they become aroused it stimulates the mind to override all possible regrets returning them to a helplessness of becoming a repeat offender.

This information is designed to send a message to all branches of law enforcement, educators, and therapists worldwide to know there is a powerful reason people are unable to control the impulses that drive humans to commit such dysfunctional acts.

THIS IS MY STORY

It started when I began to examine issues differently due to the many moral issues and experiences I have had the type that leads to believing in a creator who deals with reality and help a person reason correctly. Having insight of how we form thoughts and the desire to live a healthy productive life I began to discover that the human mind has an undeveloped potential, one that is subject to our own thoughts.

Because of my background I began to examine the issues of how certain behaviors cause a great deal of pain in myself and those who are victimized by those behaviors especially our family and my wife. Building from those personal experiences I prepared a way to deal with these issues in my own mind.

How? For example every time I would see a woman who was attractive I began to examine my thoughts directly, not allowing my eyes to turn aside in order to avoid those issues I needed to confront the problem. Looking allowed my self-talk to provide pictures and words that dealt with reality, saying to myself that people are beautiful and attractive. Slowly I began re-addressing the matter with reality statements such as "see how beautiful she is to look at." These messages began confirming my desire to be rid of the physical feelings the mind is providing the body. I used the feed back of other realities like the harm it caused the victim, my wife and me to help supply a healthier out look.

In time it began to form a new picture, by slowly beginning a process to drop and reinforce the issues that kept opening the doors to inappropriate thoughts and desires. At first the mind (or self talk) would send out the same stimulating messages leaving me subject to the physical attractions. As time went on I gained control over my body by taking the next step, (*controlling masturbation*) as it is a key in opening the mind up to more problematic developing. This allowed me (*after a few*

months) to find a new experience awaiting me the type that escapes our notice without having the experience to know what it would provide. This helped supply a completely new freedom that at first became an observation and not much more, that is until the weeks passed by and the reality started to set in.

When this was well formed within my belief system I started to notice a new freedom was being established through the subconscious mind. As this went on one day I discovered one of the most powerful freedoms imaginable, it was like the feelings one has when he is with someone new for the first time, except this time it was with my wife. When I had intercourse with her the feelings were so powerful and exciting that every time we have intercourse now it is as though I just met her, you know the kind of excitement we all find when we first meet someone we keep thinking of them often during the day and can hardly wait to be with them.

Get ready because here is the reward: Finally one day when we were having intercourse and I ejaculated I got up and in great anger I realized I never needed to act or do the things I used to believe was so great and stimulating. At that same moment I began explaining to her how my relationship with her was all I ever needed and at that moment I knew and felt what must be the greatest freedom of them all because I was able to see myself as wanting those things only! I began to weep telling her "I am so sorry for the things I did in the past" at that time a feeling of remorse came over me, one that I never new or felt before or even dreamed was possible.

Since then it has happened again and again and has become a powerful reward providing a loving interaction the kind that was meant to be between a man and his wife. The fact is I now find myself no longer wanting to separate myself from her after sexual intercourse, instead I keep telling her how much I truly love her, because now I find it desirable to hold her calling into play the same feelings I had just before the sexual interaction, the feelings that attracted me to desire that interaction was still there without the need to have sex, imagine that!

Research shows the desire for a man to have intimacy with his partner after sex is not usually there instead I feel the opposite and very content afterwards. You have no idea how rewarding that is especially for me as I always wanted to get away from a woman after it was concluded, no longer needing or desiring to touch.

This is just part of the progress I have made through knowledge I have gained concerning the creator and his purpose intended for mankind. I would never have changed nor would I have ever known the quality found in such a freedom. Thanks to God and His Son Christ Jesus I am alive and free of those burdens.

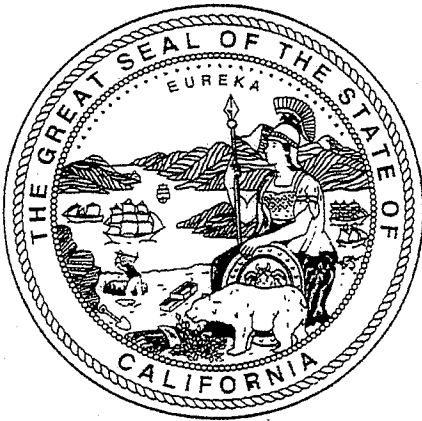


