IT IS IMPORTANT TO NOTE THAT GABRIEL'S PICTURE HAS BEEN RELEASED TO NATIONAL TELEVISION AS WELL AS ON THE WEBSITE OF THE NATIONAL CENTER FOR MISSING AND EXPLOITED CHILDREN YET HIS LOCATION REMAINS UNKNOWN AS OF 1/9/2010.
