

The Grand Jurors of Maricopa County, Arizona, accuse ELIZABETH JOHNSON, on this 14th day of January, 2010, charging that in Maricopa County, Arizona:

COUNT 1:

ELIZABETH JOHNSON, on or between the 18th day of December, 2009 and the 30th day of December, 2009, knowingly restrained GABRIEL S JOHNSON, under fifteen years of age, with the intent to place ~~him~~ Logan McCuevas (RP) in reasonable apprehension of imminent physical injury to GABRIEL S JOHNSON, in violation of A.R.S. §§ 13-1304, 13-1301, 13-705, 13-3601, 13-701, 13-702, and 13-801.

COUNT 2:

ELIZABETH JOHNSON, on or between the 18th day of December, 2009 and the 30th day of December, 2009, having the care or custody of GABRIEL S JOHNSON, a child, under circumstances other than those likely to produce death or serious physical injury intentionally or knowingly caused or permitted GABRIEL S JOHNSON'S person or health to be injured or to be placed in a situation where his health was endangered, in violation of A.R.S. §§ 13-3623(F)(B)(C), 13-3601, 13-701, 13-702, and 13-801.

COUNT 3:

ELIZABETH JOHNSON, on or between the 18th day of December, 2009 and the 26th day of December, 2009, did conspire to commit the offense of Custodial Interference. In conspiring to commit such offense, Elizabeth Johnson and other conspirator(s), both known and unknown, with the intent to promote or aid the commission of an offense, did agree with one or more other persons that at least one of them or another person would engage in conduct constituting the offense of Custodial Interference. A.R.S. §§ 13-1003, 13-1302, 13-3601, 13-701, 13-702, and 13-801. In furtherance of this conspiracy and to effect the objects therefore, defendant and other co-conspirator(s) both known and unknown would commit overt acts in violation of A.R.S. §§ 13-1003, 13-1302, 13-3601, 13-701, 13-702 and 13-801.

COUNT 4:

ELIZABETH JOHNSON, on or between the 18th day of December, 2009 and the 26th day of December, 2009, removed GABRIEL S JOHNSON from Arizona, knowing or having reason to know that she had no legal right to do so, took, enticed or kept from lawful custody, GABRIEL S JOHNSON, a child, who was entrusted by authority of law to the custody of ~~GABRIEL S JOHNSON~~ ^{Loan} ~~McCahey~~ ^{RP} JOHNSON, in violation of A.R.S. §§ 13-1302, 13-3601, 13-701, 13-702, and 13-801.
