He punched me in my face ~~and~~ charged after to me and pushed me on to the street (North St) broke my glasses, came after me again and I was already up and running after my daughter and boyfriend to get in their car. He sliced all my tires on both vehicles so I could not leave but lucky I had my daughter & boyfriend car. On the 3-4-06 early morning he ~~was~~ kicked me in the stomach, when I was sitting on the chair in the kitchen he would come in and try to push me off because he wanted to sit there, when he climb up to the attic to get the Bow at that I fear for my life and my daughter and boyfriend that when we were leaving and that when he sliced my tires punched me the face - pushed me to the ground like he was making a brick wall.
