The Defendant is entitled to the above information pursuant to Fla.R.Crim.P. 3.140(n) in that the Information or arrest report fails to inform the Defendant of the particulars sufficiently to enable him to prepare his defense. The lack of specificity of particulars is not within the readily ascertainable knowledge of the Defendant, and he is embarrassed in the preparation of his defense or may be exposed to substantial danger of a new prosecution for the same offense.

by and through her undersigned attorney and hereby waives arraignment in this cause.


