ON 8-11-10 AT 2130 HRS, SGT S. CLARK (UNIT #3796) RECEIVED A PHONE CALL FROM TPR. PAUL GONYEAU (MICHIGAN STATE POLICE- PH #269-214-8807). GONYEAU ADVISED THAT HE RECEIVED INFORMATION THAT THE SUSPECT, ELIAS ABUELAZAM, WAS WAITING TO BOARD A FLIGHT TO TEL AVIV, ISRAEL AT GATE E-17. OFC OVERSTREET, OFC J. RIVERS, OFC M. TURNER, AND SGT CLARK RESPONDED TO THE GATE AND HAD THE SUSPECT PAGED OVER THE INTERCOM. ABUELAZAM WAS DETAINED WHEN HE APPROACHED THE TICKET COUNTER. AFTER VERIFYING HIS IDENTITY, HE WAS TRANSPORTED TO THE AIRPORT PRECINCT. GONYEAU WAS NOTIFIED AND HE ADVISED THAT HE WAS GOING TO FAX A COPY OF THE WARRANT. HE ALSO ADVISED THAT SEVERAL INVESTIGATORS FROM THE MICHIGAN STATE POLICE WERE GOING TO ARRIVE AT H-JAIA AT 0300 HRS TO INTERVIEW THE SUSPECT. MAJOR PROPES, SA CHENEY (FBI), R. EDWARDS (FEDERAL AIR MARSHALL SERVICE), JOHN KENNEDY (H-JAIA PUBLIC AFFAIRS), CPT. HOBBS WERE NOTIFIED.

AT 0400 HRS ON 8-12-10, INVESTIGATORS FROM THE MICHIGAN STATE POLICE ARRIVED AND A COPY OF THE WARRANT WAS FAXED TO THE AIRPORT PRECINCT. THE SUSPECT AND INVESTIGATORS WERE TRANSPORTED TO THE APD HOMICIDE OFFICE WHERE SGT CREASY WAS ABLE TO SECURE TEMPORARY HOUSING FOR THE SUSPECT AT THE CITY JAIL.
