4. If you cast a vote for a candidate whose name is printed on the ballot, do not write that candidate's name on the write-in candidate line.

5. To cast a write-in vote, darken the oval to the left of the line provided and write in the candidate's name.

6. If you make a mistake or want to change your vote, please return your ballot to an election official and obtain a new one. You may ask for a new ballot up to two times.

Do not attempt to erase or cross out any marks made in error.

An additional tax for the benefit of the Jefferson County Joint Vocational School District for the purposes of **current expenses; purchasing equipment for buildings; and improving buildings** at a rate not exceeding 1 mill for each one dollar of valuation, which amounts to \$0.10 for each one hundred dollars of valuation, for 10 years, commencing in 2012, first due in calendar year 2013.
