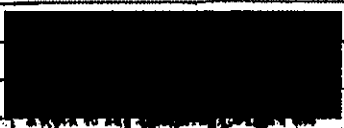

Then a man came down the side walk w/ a flash light to the man who was standing + they were talking. But I was frightened to see the other man still on the ground. I then saw the man who got up put his hands up + another man came w/ flash light + he hand cuffed him.

The voices stopped, but when I laid on my bed to read, I heard the loud voices again and got up to look to see who it was. I had to open the window to see. But, because it was dark + I had my night light on to read I could not see anything with the glare. So I shut the light off and kneeled down to look out the open part of the blinds, now I had a clear view of two people on the ground one on top of the other. At that time I felt that something horrible was happening, knew I had to

I believe it was not the loud voice I heard in the argument, or the aggressive ^{voice} I heard earlier. I was on the phone with 911 man and was telling him something horrible is happening and asked him, if he can hear it I placed my phone to the window screen as I was watching. As I watched bare man on top of another man on the phone I heard a popping noise and continued to tell the 911 man hurry hurry and get some one here. Shortly after a man got up, he was a broad built man and walked approximately 10ft to 20ft away from the other person who was still

Now I watched a man with a flash light run down the sidewalk and talked to him: (the broad built man). Next another man came running down the same sidewalk and approached the broad built man to his back, he had his both hands up ^{now} and that man had cuffed him. Next the man who did the hand cuffing appeared to be a police officer and he took him away. The person on the ground still remained motionless. Now I can hear all sirens and police running to the scene. I remained on the phone with Gillman because I still was shaken.

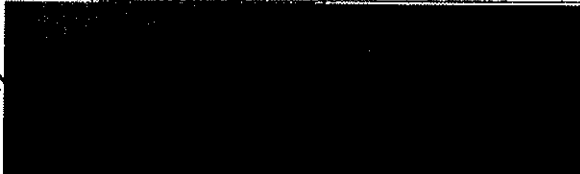

He stood up and took a couple of steps away and put his hands on his head then walked back over to the guy on the ground. He looked at him for a minute then started to walk away toward the road. That is when the police walked up.

It looks like the man was wearing a big red & black shirt, and jeans. The shirt had a type of pattern like squares or plaid. He had short hair. He looked to be around 5'9 in height.
