These can be addressed tomorrow. Enjoy your day.

First: You suggested a meeting be set up with Krelow to meet with Schultze to discuss the 2009 budget surplus numbers on April 12th. It's on your calendar, but I don't recall you wanting to be a part of that discussion. I thought it was to be Manske and Kreklow with Schultze. Is that accurate or do you now want to be a party to that meeting?

Second: John Chianelli and Tim Schoewe have been directed to set a meeting with Ernie Franzen for no later than Thursday. John hopes the CMS letter will arrive on Wednesday, but with this being a holiday week, it could be delayed. I asked that they set the meeting time for late on Thursday, just in case it arrives, but that it's important that they meet to discuss the reasons for not commenting. John asked if it could include Camelli and I said that would be okay, if Schoewe has no objection.

Third: Chianelli reports that an MD was hired during his absence from work. The Medical Director did follow all professional channels to determine credentials, but failed to Google or MySpace the individual.
