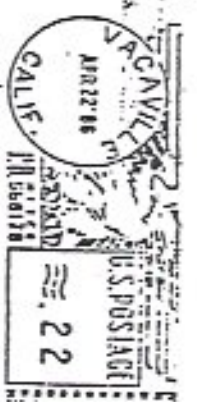

trial. This I am asking for is what I have


