I, KAREN M. WILLIAMS, being first duly sworn upon oath says:

1. I am a resident of the State of Nevada.
2. I am the daughter of RILEY B. KING.
3. That I have personal knowledge of the following: from October 2014 until May 2015 I witnessed Louise Laverne Toney and Myron Johnson, who are medically unlicensed, administer medications, fluids, and foreign object to the person of Riley B. King. I also witnessed neglect of Mr. King's medical care by administration of alleged medication to induce a diabetic shock, since his blood sugar would not be monitored for up to ten days at a time.
4. I witnessed foreign substances and/ or medication that were administered locked and hidden by Ms. Toney, leading me to believe she was administering medications or poisons into Mr. King's body due to the non-transparency of her administration of said foreign objects, poisons, or medications.
5. Mr. Riley B. King was sequestered from all family members for a week prior to his death and the informant was the unlicensed individual who was administering foreign substances to Mr. King's person.
6. Ms. Toney and Myron Johnson were the ONLY individuals who were in Mr. King's presence for a week until his death. Ms. Toney was the informant named on the death certificate.
7. I believe my father was poisoned and that he was administered foreign substances to induce his premature death, and request a formal investigation into this matter.
8. Based on the administration of foreign substances by unlicensed and unscrupulous characters, I believe my father was murdered.
9. I request a toxicology analysis be conducted and/ or an autopsy, and a report of its findings be produced to properly conclude the cause of Mr. Riley B. King's death.

AFFIDAVIT OF PATTY ELIZABETH KING

I, PATTY ELIZABETH KING, being first duly sworn upon oath says:

1. I am a resident of the State of Nevada.
2. I am the daughter of RILEY B. KING.
3. That I have personal knowledge of the following: from October 2014 until May 2015 I witnessed Louise Laverne Toney and Myron Johnson, who are medically unlicensed, administer medications, fluids, and foreign object to the person of Riley B. King. More specifically, I witnessed Myron Johnson place two drops of an unknown substance on Mr. King’s tongue during evenings for months leading up to his death. I was never told what that substance was, and when I questioned what he was doing I was told by Ms. Toney, “that she had a power of attorney and was in charge of Mr. King.” I also witnessed neglect of Mr. King’s medical care by administration of alleged medication to induce a diabetic shock, since his blood sugar would not be monitored for up to ten days at a time.
4. I witnessed foreign substances and/ or medication that were administered locked and hidden by Ms. Toney, leading me to believe she was administering medications or poisons into Mr. King’s body due to the non-transparency of her administration of said foreign objects, poisons, or medications.
5. Mr. Riley B. King was sequestered from all family members for a week prior to his death and the informant was the unlicensed individual who was administering foreign substances to Mr. King’s person.
