TRO conducted the following investigation after being called out to assist Sgt. Campbell. Based on information Sgt. Campbell provided about victim being harassed by suspect previously and the fact the same suspect supposedly lived in the apartments behind victim, TRO proceeded to try and locate the suspect. After checking one apartment where a b/m of suspect's age and description supposed to live, TRO was told of another by another b/m fitting suspect's description who lived at the end apartment. The subject TRO originally spoke with was Vercelle Miller at apartment 632. She has a son 15 who was spending the night on Bridge Street, FV and a son 12 who was there and who had been there all night. TRO went to apartment 642. Ms. Carolyn Green came to the door. It was 1:20am. She was given some general information and asked about having a teenage son who may be big for his age. She said she did and TRO asked if he was there. She seemed confused and looked around for him as if she could not find him. Upon checking her daughter's bedroom he was located "sleeping" on the floor under a blanket. Her teenage daughter was in the bed. She was spoken with a little further. She advised she went to bed around 10:05pm and her son was there. Around 1:00am the doorbell rang and she got up and answered it and it was her son, Andre. He did not have a shirt or shoes on but had on green pants. He was wearing the same green pants when he was located in the bedroom. He was wet when he came in. He was still damp when TRO arrived. It had been raining for some time by then and was raining when TRO arrived at scene and beforehand. She said he told her he had been running and had fallen. She did not see any blood on him. TRO asked her about prior trouble with him and she said he was caught shoplifting at Popes in FV and returned home by FVPD without being charged. She gave TRO permission to speak with him. He was read his rights verbally. He told TRO he had been outside running around the building but denied going over to victim's apartment. He appeared to be mentally slow to TRO. He said he had talked to her before. Andre appeared to be big for his age. He appeared to be 5'10" and 165 lbs. His skin was dark and his hair was a medium flat top style. His front teeth protruded some and his eyes were sort of bulging. He is 13 yoa. He denied owning a gray hair pick that was found at the crime scene. His mom and sister said he had a pink one which was thee. He denied harassing victim before by ringing her doorbell. With his and his mom's permission, TRO took a photo TRO told them what would be done with it. He also said victim could view him in person. He was nervous about agreeing to being seen by victim in person. Victim was spoken to briefly by phone at the hospital. he had big eyes. Since she was being tended to by medical personnel, TRO did not go to the hospital to interview her further and show photos. She was still upset. TRO looked around her apartment and observed other golf clubs in her closet. The one she used did belong to her. The bedroom area was in disarray indicative of a scuffle. No signs of anything that would be contrary to what she stated happened. CCBI did process the scene. Later that date, TRO spoke to Andre by phone. His sister had called also and wanted to speak to TRO. She was not in. He advised she had found some blood on a porch near their apartment. He advised he did not have anything else to add to what he had already said. TRO met with victim at her mom's. She was still too frightened to go back to her apartment. She had already gotten her deposit back and will be moving. She was spoken to that same day/date as incident. TRO took a photo of her injuries which were facial. CCBI had done so at the hospital. Her eyes were bruised badly and her face was swollen. She advised: That the b/m suspect came in her bedroom holding a stick. She was holding a golf club that she kept by her bed. He swung at her with the stick and she blocked it with the golf club. Both broke. He slapped her in the face several times and knocked the phone from her hand with his hand. He pulled her hair and told her to "shut up bitch". She did not smell any alcohol on his breath. She was wearing panties and a gown. He pulled her panties off. They were on the bed at first but ended up on the floor during the scuffle. He pulled her gown up also. He wanted her to take it off and see her naked. He was saying things the whole time he was doing this. He said he wanted her to ride him. He told her to spread her legs several times. he said he wanted to kiss her. He slapped her 10 to 15 times. He forced her legs open. he did oral sex on her. He put his fingers in her vagina and in her anus. He did have an erection but does not think he ejaculated. She is sure it is the same guy who has been harassing her. He has been harassing her for 1 to 2 months. It started in June, '94. He did speak to her one day. She did not know his name and did not when she was raped. She knows it to be the same guy as before because she had seen him before when he rag her doorbell and ran. FVPD came out one night because he was ringing the bell. She knew he lived behind her in the other apartments because when she described him to the apartment manager from the doorbell incidents she told her he lived there. She was not sure which one but thought it to be an end one. She noticed his big eyes then as she did in this incident. TRO spoke to Margaret Messer, the apartment manager. She advised she was familiar with suspect and the doorbell incidents. She advised Catina Tucker in apartment 616 heard a scream that night and saw a b/m run out of victim's apartment door. Tucker has not been spoken with yet. Latisha Green, suspect's sister, advised she had found a blood spot on her neighbor's patio. It was raining very had all that night and it is doubtful someone's fresh blood would have dried enough to show like that. It is believed to be an old spot/stain of some kind from a previous time. On 7/27/94 the victim was spoken to again. She was shown a mugshot book containing several photos including Andre's. When she got to his photo in the book, she stated "that's him, that's the one who did it." Suspect was questioned again, this time at FVPD. His mom was with him. His rights were read by both and signed. He initially

continued to deny being involved. Then he said he was ringing her doorbell that night. That he had a butter knife with him. He brought it from home. He took off her window screen with it. A bedroom window screen was found on the ground outside her son's bedroom by TRO. He tapped on the window to get her to come to the back door. She did not respond. He went to the back door and knocked. No one came. He used the butter knife to pick open the door lock. Then he used the knife to break the glass in the back interior door. After he did this he reached in and opened the dead bolt lock and went in. He had the knife in his pocket. He ran around. He knocked on her bedroom door and he flew open. She screamed and was calling the police station on the phone. She got a golf She poked at him with it. He ran outside and got a mop handle off her porch and came back in. She swung at him and he swung at her. The sticks broke in half. She dropped the club and he dropped the mop handle. She told him not to hurt her baby. She was crying. He told her to quit yelling. He denied calling her a bitch. He jerked the phone away from her and she fell on the bed. He smacked her twice on her face and fell on her and got up. She fell on the floor. I was rubbing her stomach. Her gown flew up when she rolled on the floor. I touched her breasts. Then her panties came down. He pulled them to her knees. I continued to rub her stomach. He kissed around her private part. He put some of his fingers in her private part and her bottom. he tried to put his thing in her private part. When asked if it was in her, he said "not really". She said it won't. It was touching it. He slapped her some more. All together about 4 times. He heard a knocking and she said it was the police. She told him to let her up and she got up and screamed and he ran out the front door. He did not jump over the police car. TRO had not mentioned anything about that. He claimed people around the apartments had said that. he ran around the apartments and slipped and fell. He did tell her to get up one time and get on top of him when all that was going on. People say she is pretty. One time he saw her and she looked OK. He was never real clear about his reasons for going over to her apartment. He advised he went to tell her he was sorry for ringing her doorbell. He went to scare her and just to have fun. When asked about planning to have sex with her, he advised he though about it but did not think he would do He thought he was smarter than that. He must not have been thinking right. When asked about being sorry or it bothering him he advised he was sorry and it did bother him a little. His mom advised she asked him why he did it and he told her because she whipped him for back talking her. She advised other than the doorbell incidents and shoplifting incidents, he had not done anything like this before. She advised he was not on any medication. Michelle will be using her mom's address from now on. will not reside at the apartments anymore. She may also stay with her sister in Charlotte some. TRO obtained a secure custody order on suspect and placed him in Wake County Juvenile Court's custody for detention placement. Two petitions also obtained for Burglary and Rape. See Juvenile Custody.



TRO spoke to ADA Frank Jackson about case. Green may be tried as an adult due to the serious nature of the crimes. A hearing was held today. He was kept in custody and is now at the Raleigh Detention Center. It is possible Green may be charged with an additional charge of First Degree Forcible Sex Offense due to him inserting his fingers in her vagina and anus. A petition for same will be obtained if the DA's office advises TRO to do so. Mr. Jackson was spoken to about obtaining a court order to obtain fingerprints to compare to the crime scene's latent fingerprints and comparison with the Phillips crime scene latent fingerprints. He advised that TRO could go ahead and do so. This will be done soon.
