On Wednesday, October 7, 2009 at approximately 1116 hours I was dispatched to Interstate 4 and State Road 434 eastbound in reference to a white female, blonde hair, driving a blue Dodge Caliber waving an unknown type handgun at the complainant while traveling eastbound on Interstate 4.

Upon my arrival on Interstate 4, I requested through the Communication Center that the caller turn on her vehicle's hazards lights so I would be able to identify her motor vehicle. Once I identified the vehicle, the female caller was waving her hand out the window towards the blue Dodge Caliber in front of her. At which time I pulled in front of the callers silver Honda Accord on Interstate 4 just passing the eastbound rest area and behind the suspects blue Dodge Caliber. I followed the blue Dodge Caliber east on Intestate 4 where they exited onto Lake Mary Blvd. and as I was on Lake Mary Blvd I observed Deputy Kassa turning around to assist me with the blue Dodge Caliber. The blue Dodge Caliber then pulled into the entrance that is shared by a bank and a Mobil gas station. They parked at the Mobil gas station approximately six parking spaces from the front entrance. I would like to make note that I was advising Seminole County Communications of each event as it occurred and requested traffic as we pulled into the Mobil gas station.

I stopped my marked Sheriff's vehicle #212 behind the blue Dodge Caliber and knowing that Deputy Kassa was behind me when I pulled into the parking lot, I proceeded to initiate a felony stop. As I exited my Sheriff's vehicle I drew my handgun from behind my driver's side door and started to give the commands for a felony stop. At that time, a Lake Mary Police vehicle made an abrupt stop just inside the entrance to the Mobil gas station and the driver of the Lake Mary Police vehicle jumped out, drew his handgun and started shouting "let me see your hands, get on the ground" as he quickly approached the suspect vehicle.

At this point my initial felony stop was interrupted. I then approached the vehicle slowly while giving commands to the driver, later identified as Donna Brock by her Georgia drivers license. Donna Brock was ordered to open the drivers side door and exit with her hands in the air and when she complied she was handcuffed and walked to the rear of my Sheriff's vehicle. While walking to my Sheriff's vehicle, I informed her the reason she was being detained and handcuffed was because we were called and told that she showed an unknown type handgun to another person while driving east on Interstate 4. Donna Brock stated "we have no gun and you can search my car if you would like". I explained to her that if there is no gun found and nothing other than words were exchanged, she would be released and on her way. While I was speaking with Brock, Misty Cummings was removed and secured by Deputy Kassa and an unidentified female Lake Mary Police Officer. Shortly after she was secured, I explained to Cummings why she was being detained and she understood. I walked over to the caller and asked her what happened. The caller who was identified as Courtney Ballinger stated that while on Maitland Ave., in Orange County, and while on Interstate 4 eastbound, the driver and passenger of the blue Dodge Caliber began screaming and giving hand gestures towards her. At that time Courtney advised that she attempted to pay no attention to the occupants in the blue Dodge Caliber, but they continued to drive up beside her and make hand gestures and scream at her. Than Courtney observed the driver showing what appeared to be an handgun through the window at her. At this point she called the Sheriff's Office to report the incident because she feared for her safety.

I asked her if at any time did the blue Dodge Caliber attempt to drive her off the road and she stated no. I explained to her that we looked into the car and did not find any handguns. I further advised that based on the road rage situation it would be her word versus the other parties. Courtney appeared to me to be visibly shaken and scared due to the situation. She stated over and over again that she thought the driver had a gun. Courtney was released and subsequently Brock and Cummings were unhandcuffed and were free to return to their vehicle.

While speaking with Donna Brock she thanked me for my courtesy and she was released from the scene.
