14 The Orange County District Attorney charges that in Orange
15 County, California, the law was violated as follows:

16 COUNT 1: On or about December 20, 2011, in violation of Section
17 187(a) of the Penal Code (MURDER), a FELONY, ITZCOATL MISSAEL
18 OCAMPO did unlawfully and with malice aforethought kill James
19 McGillivray, a human being.

19 COUNT 2: On or about December 27, 2011, in violation of Section
20 187(a) of the Penal Code (MURDER), a FELONY, ITZCOATL MISSAEL
21 OCAMPO did unlawfully and with malice aforethought kill Lloyd
22 Middaugh, a human being.

23 COUNT 3: On or about December 30, 2011, in violation of Section
24 187(a) of the Penal Code (MURDER), a FELONY, ITZCOATL MISSAEL
25 OCAMPO did unlawfully and with malice aforethought kill Paulus
26 Smit, a human being.

26 COUNT 4: On or about January 13, 2012, in violation of Section
27 187(a) of the Penal Code (MURDER), a FELONY, ITZCOATL MISSAEL
28 OCAMPO did unlawfully and with malice aforethought kill John
Berry, a human being.

1 ENHANCEMENT(S)

2 As to Count(s) 1, 2, 3 and 4, it is further alleged pursuant to
3 Penal Code section 190.2(a)(3) (MULTIPLE MURDERS), that
4 defendant ITZCOATL MISSAEL OCAMPO committed at least one crime
5 of murder of the first degree and one or more additional crimes
6 of murder of the first and second degree.

7 As to Count(s) 1, 2, 3 and 4, it is further alleged pursuant to
8 Penal Code section 190.2(a)(15) (MURDER BY LYING IN WAIT), that
9 defendant ITZCOATL MISSAEL OCAMPO intentionally murdered James
10 McGillivray, Lloyd Middaugh, Paulus Smit, John Berry by means of
11 lying in wait.

12 As to Count(s) 1, 2, 3 and 4, it is further alleged pursuant to
13 Penal Code section 12022(b)(1) (PERSONAL USE OF DEADLY WEAPON),
14 and within the meaning of Penal Code section 1192.7, that
15 defendant ITZCOATL MISSAEL OCAMPO personally used a A KNIFE, a
16 dangerous and deadly weapon, in the commission and attempted
17 commission of the above offense.

18 I declare under penalty of perjury, on information and belief,
19 that the foregoing is true and correct.
