

Ritzer and the juvenile are known to each from the school.</p> <p>It was learned from an interview of the juvenile suspect and video surveillance footage recovered at the school, that a juvenile student that attends Danvers High School assaulted and subsequently murdered Colleen Ritzer and disposed of her body near the high school grounds.</p> <p>Based on his statements and the corroborating evidence found at multiple scenes at the Danvers High School and surrounding wooded area, the juvenile was subsequently placed into custody and booked for Murder</p>


