AFFIDAVIT of PROBABLE CAUSE

Your affiants on this criminal complaint are sworn police officers in the Commonwealth of Pennsylvania. The information contained in this affidavit is from information and personal observations which the affiants believe to be true and correct.

On April 9, 2014 at 07:10am Ofc William Yakshe of the Murrysville Police Department was in his office at the Franklin Regional Senior High School. He heard a disturbance in the hallways of the school. Ofc Yakshe and Sergeant Resetar, school security guard, went into the hallways to find out what was happening. They went in different directions. Ofc Yakshe came back and saw Sgt Resetar leaning against the wall and Sgt Resetar was bleeding from his stomach. Franklin Regional Senior High School Principal Sam King and the actor were observed on the floor of the hallway and Ofc Yakshe handcuffed the actor.

Sam King was interviewed and stated that he heard the disturbance, came into the hallway, and saw kids running in the hallway. Sam King heard one of the victims state "I've been stabbed". Sam King then saw the actor standing in the hallway holding two knives. Sam King observed the actor stab Sgt Resetar. Sam King then tackled the actor and subdued him. Sam King later identified the actor as Alex Hribal, a student at Franklin Regional Senior High School.

When Murrysville Police arrived at the scene multiple stab victims were observed in classrooms and hallways. It was determined by medical personnel that 20 Franklin Regional Students and 1 adult were stabbed by the actor. 4 of the Franklin Regional Students who were stabbed are presently in intensive care units at local hospitals with life threatening injuries.

After interviewing several Franklin Regional Senior High School students, they identified the actor as Alex Hribal.

I, Charles Tappe, Third, BEING DULY SWORN ACCORDING TO THE LAW, DEPOSE AND SAY THAT THE FACTS SET FORTH IN THE FOREGOING AFFIDAVIT ARE TRUE AND CORRECT TO THE BEST OF MY KNOWLEDGE, INFORMATION AND BELIEF.
